INSTRUMENT HIRE – Terms and Conditions

Hire of musical instruments are made available by Northern Rivers Music, on the terms and conditions listed below.

Hirer agrees:

- 1. To provide a nominated credit card or debit card, and that monthly direct debit payments of nominated amount agreed upon on the rental form, will be deducted from this card.
- 2. That a fee of \$5 will be incurred for a declined or expired card
- 3. That the initial hire period is for a minimum of 3 months.
- 4. That Instrument Hire can be CANCELLED at the end of any month (following the initial lease period 3 months), and that upon cancellation the instrument is to be returned to the Northern Rivers Music (60 Barrett Drive, Lennox Head) before the end of that month to avoid deduction of further payments. If posting, this will be at the Hirer's cost.
- 5. To maintain the musical instrument in good working order and to return it in the same condition as when received.
- 6. That the musical instrument remains the property of Northern Rivers Music.
- 7. That it has been recommended that I take out insurance for the musical instrument leased against fire, loss, theft and/or damage with a reputable and legally licensed insurer.
- 8. Not to sell or offer for sale, assign, , lend or otherwise deal with the musical instrument.
- 9. That the hirer is responsible for any loss or damage incurred to the musical instrument whilst in their possession.
- 10. That Northern Rivers Music will be notified of any damage or loss to the musical instrument within a period of not more than 48 hours.
- 11. That the hirer will pay Northern Rivers Music for the cost of any repairs deemed necessary as a result of loss or damage incurred. Should the musical instrument be deemed not repairable or cannot be located, the hirer will provide payment for the total value of the musical instrument. That the value of the musical instrument or the value of any repairs required to the musical instrument will be assessed by Northern Rivers Music and that that assessment is the amount payable in accordance with this term and condition.
- 12. That the hirer will not attempt to repair or adjust the musical instrument in any way.
- 13. That if the hirer commits any breach of these terms and conditions, Northern Rivers Music may, without notice, recover any of the amounts outstanding, resume possession of the musical instrument, and/or terminate this agreement.
- 14. Northern Rivers Music reserves the right to vary the terms and associated fees related to this agreement. In such cases, notification of at least 30 days will be given to all lessees.

Option of Purchase

The hirer understands that:

If they purchase the instrument at any time after the first 3 months, they will receive a credit of the rental payments already paid. This is only up to the 6 month mark. A maximum of 6 rental payments will be given in credit. After this time the monthly payments are rental payments only.
